Memorials within Desford Cemetery – Rules and Regulations

- All monuments and stones must be of natural quarried stone in keeping with the surroundings.
- Inscriptions and artwork should be in black or brown paint.
- No monument may be erected without the permission of Desford Parish Council and is subject to formal application and approval. Any memorial erected without permission will be removed.
- Copies of memorial application forms and cemetery rules and regulations are available from the website or by contacting the Clerk or Burial Officer on 01455 822993, Email clerk@desford-pc.gov.uk or in writing to Desford Library, Main Street, Desford LE9 9JP.
- Images and photographs will not be permitted.
- Monuments must not be removed, altered, or added to without the Clerk's permission.
- All monuments erected will conform to BS8415, or face being removed by the Council at the owner's cost.
- A headstone or cross shall not exceed 90cm high x 80cm wide (3ft x 2ft).
- Flat memorial stones, either on a cremation space or a burial space, should not exceeding 107cm x 107cm (3ft 6in x 3ft 6in) maximum depth 15cm (6ins).
- A vase (Inscribed with the Deceased's name) not exceeding 45cm (18in) in height
- Kerb stones and/or loose chippings are not permitted on new burials or surrounding a cremation plot. Removal of existing kerb stones may be carried out with the permission of the Clerk.
- The safety and maintenance of memorials and burial places are the responsibility of the family of the deceased. If a headstone or cross becomes unsafe, the Clerk to Desford Cemetery will inform the family, if possible, but Desford Parish Council reserves the right to lay the monument flat on the ground.
